Dear Australian Human Rights Commission,

Re: Temporary exemption from the requirements of the Federal Disability Standards for Accessible Public Transport 2002 ('DSAPT')

I refer to the email from City of Ryde Council dated 8 April 2021 and the related email response from Disability Discrimination Commissioner dated 13 April 2021. This email was in regards to the DSAPT requirement to upgrade all bus stops to comply with *Disability Discrimination Act (DDA)* 1992 before 31 December 2022.

Following the exemption guidelines provided by the Commissioner, City of Ryde Council engaged an accredited access consultant, Morris Goding Consulting (MGAC) to assist with the preparation of an exemption report (refer to the attached report).

In this application, City of Ryde Council seeks a temporary exemption to extend the DDA bus stop upgrade completion date. This temporary exemption would be for a period of five years commencing from the date of this application. Council also seeks clarification on four DDA compliance parameters such as obstructions on access paths, boarding point gradient, illumination for boarding point and kerb height.

Executive Summary

1.1 Introduction

The Applicant, City of Ryde Council, is a metropolitan local council in New South Wales. The Applicant supplies and maintains within its jurisdiction multiple bus stops that serve public bus services. The Applicant is required to meet the specifications of the Federal Disability Standards for Accessible Public Transport 2002 at each of these bus stops.

On its present projections the Applicant is of the view that it will not meet the requirement for 100 per cent of the bus stops that it supplies and maintains as meeting all of the design requirements of DSAPT by 31 December 2022.

The Applicant seeks a temporary exemption of five years' duration from compliance with the requirements of DSAPT for the bus stops that it supplies and maintains. This report has been prepared to outline and consider this application.

1.2 Basis of application

The Applicant seeks this temporary exemption given the following:

First, the Applicant has sought out opinion from key stakeholders. Although obvious access issues have been identified at some bus stop locations, on balance and in general, the level of functionality is tolerable. People with disability and their carers have developed transport strategies to meet their needs in the short term while the upgrade rollout continues (albeit delayed).

Secondly, the Applicant has been constrained in the timeliness of its bus stop upgrade program by multiple factors which are elaborated on in this report. The Applicant takes seriously its responsibilities to play its part in enabling public bus journeys that are suitable for people with a disability.

Thirdly, the Applicant has developed, and is presently implementing, a comprehensive upgrade plan to address compliance. The plan has been developed under a methodology to actively identify the bus stops that will most significantly impact and benefit residents with a disability. These locations have been prioritised for upgrade, all the while maintaining flexibility in the process to respond to community input.

Finally, the Applicant is developing a four-year Disability Inclusion Action Plan (2022-2026, currently in the consultation phase) in consultation with a specialist advisory working group. This plan will assist to inform the Applicant of the most appropriate way forward for access to public transport infrastructure within its jurisdiction, including bus stops. This plan will assist to refine the aforementioned bus stop upgrade plan and program.

2. Introduction

2.1 Background

City of Ryde Council has engaged Morris Goding Access Consulting ('MGAC') to provide an access report in relation to the public bus stops that it supplies and maintains within its jurisdiction.

MGAC is the largest accessibility consulting practice in Australia. MGAC provides functional and technical advice with respect to accessibility and inclusion, human movement, the Disability Discrimination Act, the National Construction Code, and Universal Design principles. MGAC is led by directors Nick Morris OAM and David Goding. MGAC has provided access consulting services for over 20 years for projects across Australia. MGAC has offices in Sydney, Melbourne, Brisbane, Wollongong, and Perth.

The purpose of this access report is to provide detail and discussion for an application by City of Ryde Council to the Australian Human Rights Commission for a temporary exemption from the requirements of the Federal Disability Standards for Accessible Public Transport 2002 ('DSAPT').

The scope of the temporary exemption would specifically be in relation to the completion of upgrade works at the bus stops that City of Ryde Council supplies and maintains in accordance with the target dates that are prescribed by DSAPT.

2.2 Scope and structure of report

The access report is structured as follows.

In Chapter 3 the report will state the application for a temporary exemption and the legislative basis for this application.

In Chapter 4 the report will outline the scope of this application for a temporary exemption.

In Chapter 5 the report will discuss whether an exemption is necessary.

In Chapter 6 the report will discuss why the temporary exemption will be consistent with the Objects of the Federal Disability Discrimination Act. It also provides background information explaining the factors affecting compliance progress to date, and also the outcome of community stakeholder discussions being the persons impacted on the delay to compliance progress.

In Chapter 7 the report will set out proposals for terms and conditions to which a temporary exemption could be subject.

In Chapter 8 the report will present four questions for which the Applicant seeks the advice of the Commission.



2.3 Limitations

The scope of this report is limited to an assessment of the merits of the application for a temporary exemption in the terms described above. It does not purport to provide an assessment of compliance for any other circumstance beyond this scope, and is not to be interpreted as such. No liability is accepted for the accuracy of information that was supplied to MGAC for the purposes of this assessment. Any change in the material circumstances discussed in this report can and may void the advice contained herein.



3. Application for temporary exemption

3.1 Application

The Applicant, City of Ryde Council, applies to the Australian Human Rights Commission ('the Commission') for grant of a temporary exemption from the Disability Standards for Accessible Public Transport 2002 ('DSAPT'). This application is with respect to the bus stops that the Applicant supplies and maintains within its jurisdiction.

On its present projections the Applicant is of the view that it will not meet the requirement under DSAPT for 100 per cent of the bus stops that it supplies and maintains as meeting all of the design requirements of DSAPT by 31 December 2022.

With this in mind the Applicant seeks a temporary exemption from the requirement to meet 100 per cent of the design requirements of DSAPT on or before the target dates that are prescribed by DSAPT. This temporary exemption would be for a period of five (5) years commencing from the date of this application.

The Applicant has not made any previous applications to the Commission for a temporary exemption in relation to any of the substantive matters contained in this report.

3.2 Legislative basis for temporary exemption

This application is made pursuant to the Federal Disability Discrimination Act 1992 ('DDA'). The objects of the DDA include:

'to eliminate, as far as possible, discrimination against persons on the ground of disability in the areas of: ... access to premises ... and the provision of ... services.'1

The DDA provides that:

'Commission may grant exemptions

- (1) The Commission may, on application by:
 - (a) a person:
 - (i) on that person's own behalf; or
 - (ii) on behalf of that person and another person or other persons; or
 - (iii) on behalf of another person or other persons; or
 - (b) 2 or more persons:
 - (i) on their own behalf; or
 - (ii) on behalf of themselves and another person or other persons; or
 - (iii) on behalf of another person or other persons;

by instrument grant to the person or persons to whom the application relates, as the case may be, an exemption from the operation of a provision of Division 1 or 2, as specified in the instrument.'²

The application is also made pursuant to DSAPT itself. The purpose of DSAPT is stated as follows:

'Purpose of Standards

- (1) The Disability Discrimination Act 1992 seeks to eliminate discrimination, 'as far as possible', against people with disabilities. Public transport is a service covered by the Disability Discrimination Act 1992.
- (2) The purpose of these Standards is to enable public transport operators and providers to remove discrimination from public transport services.'3

DSAPT provides that:

'Commission may grant exemptions

- (1) The following persons may apply to the Commission for an exemption:
 - (a) a person:
 - (i) on the person's own behalf; or
 - (ii) on behalf of the person and another person or other persons; or
 - (iii) on behalf of another person or other persons;
 - (b) 2 or more persons:
 - (i) on their own behalf; or
 - (ii) on behalf of themselves and another person or other persons; or
 - (iii) on behalf of another person or other persons.
- (2) After receiving an application under subsection (1), the Commission may grant the person or persons to whom the application relates an exemption from compliance with some or all of these Standards.'4

Scope of application

4.1 About the Applicant




Figure 1: Indicative map (not-to-scale) of the extents of the City of Ryde LGA. Source: City of Ryde Council

The Applicant, City of Ryde Council, is a local council that is located within the Sydney metropolitan area in the state of New South Wales. The extents of the City of Ryde Council Local Government Area ('LGA') are indicated in Figure 1 below.

The extents of the City of Ryde Local Government Area include the following suburbs: Chatswood West (part), Denistone, Denistone East, Denistone West, East Ryde, Eastwood (part), Gladesville (part), Macquarie Park, Marsfield, Meadowbank, Melrose Park (part), North Ryde, Putney, Ryde, Tennyson Point and West Ryde.

Some key demographic statistics of the City of Ryde LGA are as follows:



- The LGA has a population of approximately 133,224 residents.⁵
- The LGA is approximately 40.65 sq kms in size⁶ and contains 723 public bus stops.
- Approximately 16 per cent of residents are aged 65 or older (based on Australia wide statistics).⁷
- Approximately 18 per cent of residents have a disability (based on Australia wide statistics).8
- Approximately 6.0 per cent of residents in the LGA travel to work by bus.9

4.2 Responsibilities of the Applicant under DSAPT

DSAPT applies to providers of transport infrastructure.¹⁰ The Applicant supplies and maintains within its jurisdiction multiple bus stops that serve public transport bus services. To this extent the Applicant would be considered a provider of public transport infrastructure.¹¹

DSAPT prescribes a series of target dates by which certain elements of existing public infrastructure are to be upgraded to meet the corresponding design and performance requirements in DSAPT.¹² DSAPT assigns responsibility to meet these target dates to the providers of public transport infrastructure.¹³ It follows that the Applicant is bound to meet these target dates with respect to the bus stops that it supplies and maintains.

DSAPT states that by the target date of 31 December 2022, 'All public transport services are to fully comply with the relevant Standards'. This is inclusive of public transport infrastructure. ¹⁵

4.3 Scope and duration of exemption sought

The Applicant supplies and maintains a total of 723 bus stops within its jurisdiction. The Applicant has conducted an audit and assessment of those bus stops. The Applicant has also given consideration to its capacities to provide upgrades.

On its present projections the Applicant is of the view that it will not meet the requirement for 100 per cent of the bus stops that it supplies and maintains as meeting all of the design requirements of DSAPT by 31 December 2022.

The scope of the exemption would pertain to all DSAPT requirements for the bus stops within the Applicant's jurisdiction to the extent set out in Schedule 2 to this report.

The length of the period of exemption would be five (5) years, commencing from the date of submission of the present application.



5. Whether an exemption is necessary

5.1 Preface

The Applicant understands that when considering an exemption from the provisions of the DDA or DSAPT a threshold question would be whether an exemption is necessary. This chapter of this report considers various criteria for this threshold question.

5.2 Whether there is an arguable question of discrimination

DSAPT are disability standards that were made pursuant to the DDA.¹⁶ The purpose of DSAPT is 'to enable public transport operators and providers to remove discrimination from public transport services.'¹⁷ Under the DDA it is unlawful for a person to not meet a disability standard.¹⁸

The subject matter of this application is the timeliness of the Applicant in upgrading the public bus stops that it supplies and maintains in accordance with the target dates that are set by DSAPT.¹⁹ A failure on the part of a transport provider to meet those target dates would be a breach of DSAPT, being a disability standard that was made pursuant to the DDA.

Given the above it is submitted that there would be a question of discrimination contrary to the DDA to be considered here.

5.3 Whether any permanent exemptions can be applied

The DDA allows for the granting of permanent exemptions under certain circumstances – namely, for superannuation and insurance,²⁰ and for combat duties and peacekeeping services.²¹ The subject matter of the present application would not fall within any of the above circumstances.

5.4 Whether the 'special measures' provisions can be applied

Section 45 of the DDA makes provisions for an act to not be unlawful if that act is reasonably intended to benefit or provide opportunities for people with a disability in particular.

The issue here is the ability of the Applicant to upgrade the bus stops that it supplies and maintains to meet the design requirements of DSAPT in accordance with the target dates that are set by DSAPT. The Applicant is not intending to provide special measures to benefit

people with a disability at any of the bus stops that it supplies and maintains. The Applicant therefore submits that this aspect of the DDA is not relevant to the present circumstances.



Consistency with the Objects of the DDA

Objects of the DDA 6.1

The objects of the DDA are reproduced in their entirety below:

'The objects of this Act are:

- (a) to eliminate, as far as possible, discrimination against persons on the ground of disability in the areas of:
 - (i) work, accommodation, education, access to premises, clubs and sport; and
 - (ii) the provision of goods, facilities, services and land; and
 - (iii) existing laws; and
 - (iv) the administration of Commonwealth laws and programs; and
- (b) to ensure, as far as practicable, that persons with disabilities have the same rights to equality before the law as the rest of the community; and
- (c) to promote recognition and acceptance within the community of the principle that persons with disabilities have the same fundamental rights as the rest of the community.'22

The Applicant is seeking an exemption from DSAPT design requirements to be met at 100 per cent of the bus stops that it supplies and maintains by the prescribed target date of 31 December 2022. The Applicant seeks an exemption to continue upgrading bus stops to meet this requirement beyond the target date.

The Applicant submits that even though it will take longer for the 100 per cent level to be reached, the measures that it proposes will not diminish the rights of people with disabilities in its constituency. This is based on the following:

- Priority planning and delivery of bus stop upgrades targeted to disability movement, for immediate and widespread impact
- Updated Disability Inclusion Action Plan informing the process (with working group assembled from people with lived disability experience)
- Improved communications and feedback mechanisms to inform the process, including the flexibility to adjust the rollout plan in response

The Applicant further submits that it will put into place measures that will promote recognition and acceptance of the rights of people with disabilities in accordance with the Objects of the DDA. The Applicant proposes the following measures:

- Community wide presentations and promotions of the project, its importance, objectives and progress
- Assembling the Disability Inclusion Action Plan working group with people with lived disability experience
- Targeted communications with Retirement and Aged Care facilities, education providers, disability support organisations, community centres, transport operators, social and low income housing providers and the like

6.2 Factors affecting compliance progress

To date the Applicant has conducted extensive upgrades to the bus stops that it supplies and maintains (over 300 have been upgraded). There have however been multiple factors that have affected the capacity of the Applicant to meet the compliance requirements for the bus stops within the prescribed schedule. The principal factors are discussed in turn below.

Existing topography

DSAPT requires the flooring at the boarding point of a bus stop to be 'firm and *level*'.²³ This requirement is readily achievable on land that is already level.

The existing topography of the City of Ryde LGA is, however, not level. The extents of the LGA include the steep riparian zones along the Parramatta River to the south and along the Lane Cove River to the east and north. The extents of the LGA also include naturally hilly areas in the majority of the constituent suburbs, such as in Macquarie Park and North Ryde. The Applicant supplies and maintains numerous bus stops in all of those areas.

The requirement for level boarding point is achievable if there is scope for the land upon which a given bus stop is located to be excavated and re-built to be 'level'. This however is not always a practical possibility. The flooring of the bus stops would typically and practically follow the existing grade of the adjacent roadway and kerb. To change the flooring of the bus stops would require changing the gradient of the roadway and kerb, or else the conditions of the adjacent lots, or all of the above. Such modifications would frequently be implausible and excessive and grounds for unjustifiable hardship. There may be environmental and technological factors making such a proposal unsound (e.g. for drainage or inground services issues) or fraught with legality and ownership issues (such as for roadways and kerbs which are not under the Applicants ownership but nonetheless have a fundamental influence on the potential for accessibility at any given bus stop location).

This issue is elaborated on in detail within Section 8.3 of this report and explains in part the reduced compliance progress on sites which are naturally steep and challenging. The Applicant is also aware of the ongoing review of DSAPT, with the 2017 review delayed and set to be reported on in late 2021. It is hoped that submissions to the process addressing topography issues are reflected in a revised and modernised DSAPT.²⁴

Legacy infrastructure

The vast majority of the bus stops within the City of Ryde LGA are legacy infrastructure. The City of Ryde itself was established some 150 years ago. The locations of the bus stops predate the entry into effect of DSAPT by many decades. Further, the design of the bus stop infrastructure pre-dates the accessibility criteria of DSAPT.

This has meant that, rather than starting building bus stops from scratch (and adopting the sound and considered planning principles of TfNSW *Guidelines for Public Transport Capable Infrastructure in Greenfield Sites*), the Applicant has had to assess and modify its existing infrastructure in a piecemeal fashion.

It is noted that legacy infrastructure as a broad issue is closely related to the above point concerning existing topography. As such this issue is elaborated on in detail within Section 8.3 of this report and explains in part the reduced compliance progress on sites which are naturally steep and challenging. The Applicant is also aware of the ongoing review of DSAPT, with the 2017 review delayed and set to be reported on in late 2021. It is hoped that submissions to the process addressing topography issues are reflected in a revised and modernised DSAPT.²⁵

Coordination and direction from State authorities

As a local government authority the Applicant seeks to collaborate with the relevant State authorities in the provision of public transport services and infrastructure wherever possible. This would include with respect to planning and coordination, the ordering of priority areas, resource allocation, mutual feedback, and formulation and compliance with guidelines. The Applicants Disability Inclusion Action Plan (DIAP) aims to be well aligned with the Transport for NSW DIAP in this regard.

In practice however the degree of coordination with state authorities has been lower than would be desirable. This has resulted in delays and understanding of needs and priorities. This in turn has impacted the Applicant's ability to meet the DSAPT target dates.

Council amalgamations

During the period of 2015-2016 the state of NSW considered possibilities for amalgamations of local councils. The possibility of an amalgamation between the City of Ryde and another LGA created uncertainty for the Applicant. Of most relevance here it affected the ability for the Applicant to plan with certainty the remaining phases of the bus stops upgrades.

At the end of the investigation period it was decided that no amalgamation was to be adopted for the City of Ryde. The result of this was an *18-month delay* in the program for upgrade to bus stops.



Covid-19 pandemic

In more recent times the Applicant has been affected by the Covid-19 pandemic, starting from early in the year 2020 to the present day. In this sense the Applicant is in a position not dissimilar to other providers and operators of public transport.

For the Applicant the pandemic has meant a significant impact on funding and budgetary commitments. This has been due in part to reductions in revenue from developer levies. The Covid-19 pandemic has also meant restrictions in the availability of contractors for the construction of upgrade works for bus stops. Reduced mobility due to the pandemic and lockdown measures have impacted the Applicants ability to refine the upgrade roll out plan through further study and engagement with the community on priority issues and locations.

Progress of other Agencies and Jurisdictions

To MGAC knowledge the Applicant is the first jurisdiction, or among the earliest jurisdictions to concede a timing issue in the upgrade of bus stops to the DSAPT timeline. A cursory assessment of bus stops Australia wide reveals that there are responsible jurisdictions and agencies, numbering in the hundreds, who are clearly behind in their upgrade timeline. For example MGAC is aware of TfNSW auditing of bus stops in certain locations as recently as late 2020. The void in leadership, overall hesitancy, lack of concerted action, and uncertainty while awaiting outcomes of DSAPT modernisation, has impacted the Applicants approach to and ability to meet the DSAPT target dates. In preparation and submission of this application the Applicant is to be praised for their leadership on this issue.

6.3 Views of affected stakeholders

The ability of the Applicant to reach the DSAPT target dates would have an effect on key stakeholders in the community. The Applicant sought out the views of such stakeholders. The full list of community stakeholder organisations from which feedback was sought is contained in Schedule 1 to this report.

The community stakeholder organisations consulted with provide support services and advocacy for (but not limited to) the following individuals:

- People with mixed mobility levels and their carers (wheelchair users, people with walkers or other walking aids)
- Elderly people and their carers including those individuals living with dementia
- People with sensory impairments, such as vision and hearing, including people with aphasia
- People with cognitive impairments and their carers
- People with behavioural disorders and their carers
- People with Cerebral Palsy



It was considered that this approach provided a reasonable sample of a range of disabilities in the Ryde LGA community.

The feedback received has been paraphrased and reorganised and blended into a series of main categories as follows.

Frequency of service and the coverage of routes

Common feedback was received concerning the poor availability of timetabled services, including cancellations and the abandonment of certain routes. This had an impact on the sense of independence of certain people with disability. In some cases those individuals had to resort to the assistance of a carer, or understood that their excursion would be unnecessary lengthy due to waiting times between services (this was a particular concern in summer months due to exposure). These issues were somewhat mitigated by the excellent assistance offered by many drivers.

People that raised the above issues noted that the design of the stops, and any apparent deficiencies, were not a major concern and did not impact on their use of the transport service.

It is noted that transport routes and frequency of services are not the responsibility of the Applicant under DSAPT.

Adequacy of stops

Feedback received reconfirmed the importance of unencumbered access to bus stops, the evenness and quality of surface finish, and manageable slopes and gradients. There was general consensus that on balance most stops in the area provide adequate functionality and stops with major access issues are in the minority. There was also an acknowledgement of the role that topography plays in the accessibility of certain stops. It was found through feedback that people are making planned decisions about destinations and will not actively seek a destination where the general topography surrounding the stop is known to be unmanageable (e.g. a major shopping centre may be surrounded by several bus stops but there is likely to be a preferred bus stop that provides the best access alternative to the shopping centre entrance).

Comment was also made that timetable information displayed at stops is sometimes difficult to read or comprehend, and there is a lack of real time information on the progress of the service.

In spite of the issues raised the feedback indicated that there is a sense of acknowledgement of the upgrade program occurring in the background. For example a resident commented that earlier access issues identified at a key bus stop location (at Top Ryde) have since been rectified.

It is noted that issues concerning the publication of timetables and other information at stops are not the responsibility of the Applicant under DSAPT.



Waiting experience

A wide range of quality feedback was received relating to the experience of waiting for the transport service at the stops, and this would appear to be the main concern for the majority of passengers.

Shelter coverage was frequently cited. A common issue (although not necessarily widespread) is the lack of shelters altogether at some locations, the obvious issues being exposure to sun, wind and rain. Often a shelter is in position but due to its design it does not provide adequate coverage, or the coverage intent is limited and short-sighted (e.g. the shelter may only be sized for the bench seat under meaning wheelchair waiting space is outside the outline of the shelter). Positive feedback was received praising the functionality of recent installations of modern shelters.

Lack of seating, with or without a shelter, is a key issue as waiting times for the service are often unpredictable. The fatigue factor is a major concern for some people who have already expended energy to reach the stop location. Even stops with seating are sometime unusable if wetted by recent rain (including some under cover by shelters). It was also noted that seating is sometimes positioned in a hazardous location that can dissuade their use (such as within retail precincts under building awnings where they are placed at the road edge to prioritise open shopfronts).

It is noted that the provision of shelters and seating is not an essential responsibility of the Applicant under DSAPT. However the Applicant is making every effort to provide shelters and seats at bus stops where possible.

Alternative transport

Some feedback received noted that there are disabled members of the community who, for a variety of reasons, actively avoid transport by bus. This was not a reflection of the adequacy of bus stops in the area. Rather this is an acknowledgement that there is sound reasoning for other preferred modes of transport.

For example there are people with a mobility impairment with a carer who have the availability and convenience of private transport. This is sometimes linked to the severity of that individuals disability which can make travel by bus impossible. In other cases buses were avoided in favour of the use of taxi and train due to that individuals particular cognitive and/or behavioural issues which made the experience of travel by bus too challenging. Another simple explanation is that wheelchair users cannot effectively reach the bus stops because of the challenges in using the connecting infrastructure, such as pathways on steep roads. In these case other transport modes are favoured.



7. Proposed terms and conditions

7.1 Introduction

The Applicant understands that the Commission has the discretion to set terms and conditions for the grant of any exemption from DSAPT.

The Applicant respectfully submits for the consideration of the Commission the following terms and conditions for any exemption from DSAPT.

7.2 Bus stop upgrade plan

The Applicant would commit to a comprehensive plan to the bus stops that it supplies and maintains as described in Schedule 2 to this report. This process has already started. The Applicant would commit without exception to this plan.

The plan has been developed by the Applicant to actively identify the bus stops that will most significantly impact residents with a disability and then prioritise those bus stops for upgrade.

The prioritisation methodology can be generally described as follows:

- Access to key centres, facilities and amenities. Stops which service essential key centres and facilities, such as retail, education, healthcare, and community centres will be prioritised. Locations known to accommodate persons with disability such as retirement and aged care facilities, disability support service providers and social and affordable housing centres will also be prioritised.
- 2. Patronage data. Stops with the highest usage (informed by Opal data) will be prioritised in order to allow the upgrade benefits to flow through to the widest segment of the community as quickly as possible.
- 3. *Upgrade cost.* Stops with the most affordable costs to upgrade will be prioritised in order to allow the largest number of stops to fit within the earliest budget cycles.
- 4. *Metro route*. Stops associated with a Metro route are prioritised in order to complete the accessible interchange experience for the community as early as possible.
- 5. *Existing gradient*. Stops with shallow existing gradient are given priority given these locations are already likely to be favoured by individuals with mobility issues.

A representation of the effectiveness and merit of the above described upgrade plan can be seen in Schedule 4 to this report. This map provides a graphic overlay of the location and distribution of 223 bus stops near key facilities to be upgraded before 31 December 2022.

7.3 Continuing customer and community engagement

The Applicant would commit to continuing to receive regular feedback from customers on the efficacy of its bus stops. If and when there is a critical mass requesting upgrade to a particular bus stop the Applicant commits to fast-tracking that upgrade to meet DSAPT.



7.4 Disability Inclusion Action Plan and Working Group

The Applicant would commit to the development and adoption of a new four-year Disability Inclusion Action Plan 2022-2026. This process has already started.²⁶

To aid the development of this plan the Applicant will establish a working group of 6 to 10 members, to be known as the 'Disability Inclusion Action Plan Working Group.'²⁷

It is proposed for the terms of reference of this group to require not less than three of the group's membership to include people with lived experience of disability.²⁸ It also proposed for the group's membership to include not less than three individuals that are either disability carers, service providers, community members, or people with specialist knowledge.²⁹ It is noted that a key focus area for the group is to include the provision of input on access to transport.³⁰

This group and the proposed plan will provide specialist input for the Applicant in its policies and procedures around disability. It will sharpen the Applicant's appreciation for disability needs and awareness. The Applicant intends to make use of both this plan and the specialist input to inform its approach to the provision of access to the Applicant's infrastructure, including its bus stops.

In accordance with the NSW Disability Inclusion Action Plan guidelines, the Applicants new DIAP, when complete, will be submitted to the NSW Disability Council and Department of Community and Justice.

The Commission would be welcome to contact the Applicant in relation to this plan.

7.5 Measures proposed to minimise or reduce any hardship

The Applicant would commit to the following initiatives to minimise and reduce hardship for members of the community when accessing bus services. This is in parallel with the upgrade rollout.

Communications and Education

The Applicant will promote the access upgrade plan by the following methods:

- Website home page banner link
- Printed ratepayer mail brochures (an article within the standard newsletter)

- Specific printed information mailed to Retirement and Aged Care facilities, education providers, disability support organisations, community centres, transport operators, social and low income housing providers etc.
- Information at Council offices
- Letterbox drop at residences affected by an impending upgrade (and likely temporary closure of a bus stop)

This information in the above will cover:

- Background and intent
- Rollout progress
- Upcoming locations for upgrade
- A variety of feedback options (including for the below "Report an Issue" function)

The information will be updated at reasonably frequency.

Reporting of Issues

The Applicant will modify the current "Report an Issue" functionality of its website to include a category for "Bus Stop Accessibility". The introduction of this added functionality will be included and publicised in the documentation from the aforementioned section. Feedback from this source will flow through to the bus stop upgrade plan for consideration and implementation.

Orientations

The Applicant will allow for orientations on a request basis, where considered the most suitable response to a feedback issue e.g. a resident concerned by the temporary closure of a stop during its upgrade.



8. Questions to the Commission on compliance with DSAPT

8.1 Preface

In the Applicant's experience there are aspects of the design requirements of DSAPT for bus stops that are uncertain in their application in practice. This uncertainty has had, and continues to have, a material impact on the assessment, design, and delivery of the upgrades of the bus stops that are supplied and maintained by the Applicant.

The Applicant is keen to not provide unsuitable outcomes in its pursuance of DSAPT compliance at the bus stops that it supplies and maintains. To aid the appropriate delivery of compliance with DSAPT the Applicant respectfully seeks the Commission's view on four questions on the application of DSAPT.

The Applicant maintains that following exhaustive auditing and consideration of upgrade potential at all locations, that full technical compliance with the background DSAPT requirements behind these questions is not achievable at all locations. Aside from seeking the view of the Commission on these points the Applicant is also aware of the ongoing review of DSAPT, with the 2017 review delayed and set to be reported on in late 2021. It is hoped that submissions to the process addressing the substantive matters behind the following questions are reflected in a revised and modernised DSAPT.³¹

8.2 Question 1: Obstructions on a path of travel at a bus stop

The issue

DSAPT requires the provision of 'access paths' for pedestrians at a bus stop.³² DSAPT requires those access paths to comply with specific provisions of AS1428.2.³³ All such clearances must not be encroached upon by permanent fixtures. This would be inclusive of the bus stop pole and any bus stop shelter or seating element.




Figure 2: Plan view (not-to-scale) of a hypothetical example of a bus stop. (Image source: MGAC)

Figure 2 shows a hypothetical example of a bus stop that includes a bus stop shelter. It is assumed that all clearances between fixtures at this hypothetical bus stop comply with DSAPT.

In the above example a pedestrian could follow the footpath as indicated via the overlaid dashed arrow. That pedestrian could pass the shelter structure without any hindrance.




Figure 3: Plan view (not-to-scale) of a hypothetical example of a bus stop that sits on a narrower overall footpath. (Image source: MGAC)

In practice however the clearances that are available between the kerb line at the roadway and the bounding line of private property, public reserve etc. will be significantly less than what would be indicated in Figure 2. Such a hypothetical bus stop is indicated in Figure 3 below. It is once again assumed that the clearances at the bus stop satisfy all minimum design requirements of DSAPT.

In Figure 3 the fixed shelter is located within the direct through-line of a pedestrian footpath. This means that in order to pass the bus stop shelter a pedestrian would be obliged to travel *around* the shelter structure, as per the overlaid dashed arrow.

There could be a view that the shelter would constitute a physical obstruction for that individual. If the shelter were considered a physical obstruction that was contrary to DSAPT then the presumed solution would be to remove the shelter altogether.

For the Applicant this would materially impact the compliance status of its existing bus stop infrastructure. It would also materially impact the Applicant's ongoing upgrade plans for bus stops.

Question

The Applicant respectfully seeks the view of the Commission as to whether a complaint path of travel involving change of direction around bus stop shelter and seating elements is all that is required under DSAPT.

8.3 Question 2: Gradients of flooring at a boarding point at a bus stop

The issue

Each bus stop will typically have one boarding point. For both premises and infrastructure for public transport, DSAPT states that:

'Boarding points and kerbs

Operators and providers may assume that passengers will board at a point that has a firm and *level* surface to which a boarding device can be deployed.'³⁴ [Emphasis added.]

There is no definition in DSAPT as to what is meant by the term 'level' within the context of boarding and disembarkation of passengers. Further, DSAPT does not adopt by reference any Australian Standard or other standard in relation to what is meant by the term 'level' within the context of boarding and disembarkation of passengers.

As a comparison AS1428.1(2001) defines a 'landing' as 'A flat or crowned surface with a gradient not steeper than 1 in 40.'35 Landings are required at ramps and doorways. There is however no provision in either DSAPT or AS1428.1(2001) that defines a 'landing' as being the same as a 'boarding point'.

In practice the Applicant can achieve a fall of 1 in 40 or shallower *perpendicular* to the kerb at the bus boarding point, otherwise known as the cross fall. However the fall of the surfacing *parallel* to the kerb, known as longitudinal gradient or end-fall, typically follows the gradient of the adjacent vehicular roadway and kerb. At a significant proportion of the bus stops that are supplied and maintained by the applicant the gradient of the roadway exceeds 1 in 40. This

means that the end-fall of the boarding point (the direction parallel with the kerb and the roadway) would also exceed 1 in 40.

Question

The Applicant respectfully seeks the view of the Commission on the reasonableness of the flooring of a boarding point at a bus stop that has end-fall gradients steeper than 1 in 40 due to it matching the kerb and roadway profile.

8.4 Question 3: Illumination at a bus stop

The code

For both premises and infrastructure for public transport Part 20.2 of DSAPT states that:

'Illumination levels — premises and infrastructure

Any lighting provided must comply with minimum levels of maintenance illumination for various situations shown in the notes to AS 1428.2 (1992) Clause 19.1, Illumination levels.'



The notes to Clause 19.1 of AS 1428.2(1992) provide minimum levels of illumination, measured in lux, for a number of specific circumstances. Amongst the circumstances that the notes to Clause 19.1 address are entrances, stairs, ramps, lifts, toilet and locker rooms, counter tops, and telephones. None of these elements are provided at any of the bus stops that are the subject of the present discussion.

Of the remaining circumstances that would be relevant Clause 19.1 of AS 1428.2(1992) states that:

'1 The following minimum levels of maintenance illumination are recommended: ...

Passageways and walkway s150 lx ...

General displays 200-300 lx ...

- 2 Many people require better artificial lighting than is normally provided. This applies particularly to older people and to all people with impaired sight.
- 3 For people with impaired hearing, a level of illumination of not less than 150 lx, without glare, is needed to allow for lip reading.'

Discussion of application of requirements of notes to Clause 19.1 of AS1428.2(1992)

All of the bus stops that the Applicant supplies and maintains are outdoors. Based on TfNSW standards for infrastructure an outdoors bus stop at night time can be expected to achieve illumination in the order of only 42 lux.³⁶ At a bus stop with no shelter the level of illumination can be expected to be less. For a bus stop that is physically proximate to retail and commercial areas the degree of illumination could be affected by those retail and commercial premises and the timing of their operations.

There would be no technological bar against the provision of the above degrees of illumination at an outdoor bus stop. It could, for example, be achieved with (and is likely to require) floodlights. It is contended however that the provision of this level of illumination at outdoor bus stops would be unreasonable.

First, attention should be given to the main text of Clause 19.1 of AS 1428.2(1992) itself, as opposed to the notes that appended to the main text. The text states that:

'Illumination levels shall be uniform and comply with the requirements for maintenance illumination set out in AS 1680.2.'37

AS 1680.2 is a standard for *interior* lighting.³⁸ Apart from AS 1680.2 no other standard is referenced. An implication should be drawn here that the minimum illumination requirements of Part 20.1 of DSAPT were intended for interior conditions, not exterior conditions.

Given the external context the Applicant submits that the better outcome would be for external public bus stops to be designed to comply with public road lighting requirements of AS/NZS 1158 series. The AS/NZS 1158 series is the suite of standards for lighting for roads and public places.

Secondly, the vast majority of the bus stops that are provided and maintained by the Applicant are located not only in external contexts but in suburban residential contexts. Even if the levels of illumination that are required by the notes to Clause 19.1 of AS 1428.2(1992) were to be met it is argued that such degrees of illumination would, in such contexts, be excessive and disproportionate for the neighbouring residential properties at night. There may also be unintended safety issues for casual drivers introduced by such excessive lighting.

Thirdly, bus passengers and drivers would not rely solely on the illumination at the bus stops itself. This is already occurring in practice. Drivers must already be familiar with the route and location of stops to independently and successfully navigate the route in all conditions. Drivers are in anticipation of upcoming stops and will rely on the bus headlights to identify waiting passengers. All bus conveyances also have their own consistent levels of internal illumination, and further spot illumination is provided at the doorway linked to the drivers operation of the door. All of this would aid in boarding and disembarkation for passengers. This would also aid in communications between passengers and the bus driver and facial recognition. Drivers routinely assess the requirements of their passengers with obvious additional needs and consult with them on safer drop off points beyond the formal bus stop location, including to better lit locations. There is a system for drivers to report on deficiencies and unsafe situations at stops for future resolution. Further, the newer bus vehicles that are, and will be, used on bus routes within the Applicant's jurisdiction have LED beam headlights that can be angled to light up pedestrians. The Applicant is also part way through a street lighting renewal program, replacing existing lamps with white LED fittings. These fittings provide superior night-time definition of concrete edge surfaces and linemarkings. This renewal program is more than 55% complete and involved the upgrade of 4750 streetlights to LED.

Question

The Applicant respectfully seeks the view of the Commission on the reasonableness of the requirement of Part 20.1 of DSAPT in the context of external bus stops, especially in suburban areas.

8.5 Question 4: Kerb Heights

The code

For both premises and infrastructure for public transport Part 8.1(2) of DSAPT states that:

'Boarding points and kerbs

If a kerb is installed, it must be at least 150mm higher than the road surface.'



Discussion of application of requirements of DSAPT Part 8.1(2)

It is noted that the design and features of bus conveyances have evolved markedly since the formulation and introduction of DSAPT. At the time the solution to bus boarding was envisaged as the deployment of loose ramps or hinged flaps at the front doorway of the bus. The 150mm kerb height requirement matched an industry standard for roadway construction and ensured that the ramping solution would not be unduly steep or so long as to occupy too much of the boarding point to be unworkable.

It is now the policy of the State Transit Authority that all new buses acquired feature "kneeling" suspension. This is a feature by which the driver is able to manipulate the suspension system to lower the bus at the entry door for level access and boarding. Such conveyances now account for over 88% of the STA fleet, and over 80% of the private operator fleet in metropolitan Sydney. Industry advice suggests that "kneeling" can reach close to ground level, rendering the strict requirement for 150mm minimum kerb height as redundant.

Question

The Applicant respectfully seeks the view of the Commission on the reasonableness of the 150mm minimum kerb height at bus stops given the capabilities of modern buses to "kneel" to levels much lower than this, and the majority (and growing) share of such conveyances in both public and private fleets.






